Dekha Ek Khwab To Yeh Silsile Hue... an unforgettable track that is synonymous with Bollywood romance is also an epitome of the Silsila, which started with a Khwab of Uma Dutt Sharma for his fourteen-year-old son. The father's dream became reality through the illustrious musical trajectory of the legendary Indian classical musician and santoor player, Pandit Shivkumar Sharma.

The santoor was earlier known as the Shata-Tantri Veena which was used to accompany a particular type of folk singing known as Sufiana Mausiqi, popular in Jammu & Kashmir.

Since the age of seven Sharma started playing the tabla. His knowledge of 'raagdaari' as a vocalist and playing tabla helped him learn its intricacies as Sharma mentioned in his autobiography--Journey with a Hundred Strings: My Life in Music (2002).

It was Sharma's perseverance that made santoor an important component in classical renditions globally. Sharma later modified santoor to suit the requirements of Indian classical music by enhancing its tonal quality. He was the first musician to play the instrument, weighing eight kilograms, on his lap for hours at a time. Pt. Shiv Kumar Sharma with his heartfelt santoor performances soon blossomed into a versatile musician.

In 1956, he composed the background music for one of the Indian classic films Jhanak Jhanak Payal Baje, directed by V. Shantaram. In 1960, he recorded his first solo album. In 1967, he teamed up with Hariprasad Chaurasia and guitarist Brij Bhushan Kabra to produce a concept album, Call of the Valley (1967), which was one of Indian classical music's greatest hits.

The songs he composed for Bollywood director, Yash Chopra, have been loved, sung, remixed, and rediscovered. It was the santoor maestro Shivkumar Sharma along with flutist, Chaurasia, who gave the romance in Bollywood the apt rhythm and soul in many films including Silsila, Chandni, Darr and Lamhe.

Sharma was awarded the Sangeet Natak Akademi Award in 1986; The Padma Shri in 1991; and the Padma Bhushan in 2001. Though the nation mourned the demise of this 84-year-old legend, the path created by him for the santoor will forever be etched deep in our hearts and souls. -Atashi Bhattacharya

## India's standpoint in the Russia-Ukraine war

With the ongoing Russian invasion of Ukraine, the world has been divided into two geopolitical blocs - The West who have decided to punish the Russian President Vladimir Putin by boycotting Russia from every front and the ones who have decided to abstain from voting on this issue. Amongst the countries who have withheld from United Arab Emirates, Israel, Turkey have also abstained from voting. But, none of these countries had come under the kind of pressure and public criticism from the West the way India had. The West led by USA strongly wanted India on their side in order to gain a strong hold against Russia even after being aware of India's dependence on



choosing parties, India has garnered different reactions from the world for its stance of staying 'neutral'. While the European and the American officials were busy in persuading and employing various tactics to draw India away from 'neutrality', India has decided to not waver from its decision. By refusing to be a part of this bloc politics and sticking to prioritizing own interests amid the ongoing churn in global order, India, as a big, strategically important power has invited a lot of global attention.

As the war entered the third month, it was clear that Russia was unable to get a clean victory as per their original plan. With Russian troops not backing off and Ukraine supported by the western bloc defending hard, it has become a crucial geopolitical issue. The Ministry of External Affairs (MEA) has, however, said that India's stand on Ukraine, and its attempt at presenting a neutral stance has not changed "one bit" so far.

stance has not changed "one bit" so far. With Russia and USA increasing war rhetoric over Ukraine, India stayed clear of picking any sides. The West had imposed massive sanctions on Russia and have begun supplying weapons to Ukraine and supporting them on world stage. The war seemed far from ending.

While India was not the only country that had refrained from choosing sides; South Africa, The

Russian arms, the compulsions in maintaining that stock and the restrictions that such a dependence posed on India's strategic choices.

Like any other country, India also retained the right to take decisions based on pragmatic realism and its own national interests. And India believed that a neutral position anchored in strategic autonomy which kept channels open on both sides.

While India had always been known as a peaceloving country, it had not condemned Russian attack on Ukraine. It did not mean that India supported the war and still called out for peace. With situation in Ukraine ; still not under control, the atrocities committed by the Russian troops in the suburbs of Kiev, which gained heavy media coverage from round the world, the countries that were seen to be supporting Russia were set to face backslash from the global communities. While the West could ill afford to cut away from India at this point, as it needed India's markets, Joe Biden still called India's decision of staying neutral 'shaky'.

India's stance in Russia-Ukraine war has been quite diplomatic. While the pressure on India had still not subsided, India kept its stance as an independent nation which kept its own interests and benefits above the world geopolitics. -Vaishnavi Shukla

## India stands as a big brother to Sri Lanka

Sri Lanka has been burning for months. The people of this peace loving island are in continuous and relentless danger. Political instability erupted in the form of large scale protest. The country is experiencing its worst economic crisis of all time. Sri Lankans were irked by the government's miss management of financial affairs, corruption and bad judgement on initiatives that backfired, leaving the country impoverished in terms of lancing foreign exchange. This shortage of foreign currency has left the government unable to pay for essential imports including fuel, leading to debilitating power cuts. Ordinary Lankans were also dealing with shortages and soaring inflation. The Rajapaksa clan has ruled Sri Lanka's politics from pass two decades. Presently, Mahinda Rajapaksa was the Prime Minister of the country where his brother Gotabaya Rajapaksa was the president. Mahinda Rajapaksa had to resign as the Prime Minister of Sri Lanka after his supporters attacked anti-government protesters and sparked a day of violence. A day after a pro Rajapaksa mob went on a rampage at agitation sites in capital Colombo and in Central Kandy district.

Nearly 220 persons were admitted to the hospital because of the injuries in the brutal assault and in the targeted, violent retaliation by incensed citizens. Dozens of houses belonging to ministers and member of the parliament, including the Rajapaksa's ancestral village home, were torched. As Sri Lanka's economic crisis deepened, India had rushed to assist the island nation. Previously, India had its own political interests in Sri Lanka and had even earned the fury of the island nation, but that is no longer the case. This time is for India to rethink its role in Sri Lanka while also becoming a stronger and more mutually beneficial partner. After China's entry into the South Asian region through the Hambantota Port project. India had to reconsider its regional power strategy and keep China at bay- both as a geostrategic adversary and as a source has of border disputes. The situation had rendered the Sri Lankan government unable to import paper for the printing of exam papers, and the print media is already feeling the strain of a paucity of paper for printing newspapers, with prominent newspapers issuing slim editions these



days. Rising living prices, petrol, gasoline, and commodity shortages all over the country.

For now, New Delhi will continue to provide Sri Lanka with economic support but not political support during the current crisis. Detailing India's assistance to Sri Lanka in the past few months, the Ministry of External Affairs (MEA) spokesperson said that, "India has extended support what more than \$3.5 billion, and that the people of India have provided assistance for mitigating the shortages of essential items such as food, medicine etc. The support package includes a billion-dollar credit line for essential imports and half a billion-dollar line for fuel, debt payment deferrals of loans totally a billion dollars and \$400 billion-dollar currency swap that has been extended until mid-July".

Apart from the credit lines and debt waivers, the government and the Tamil Nadu government has send consignments of rice and other supplies, hoping to help tide over the crisis.

India has also committed to help Sri Lanka with a bailout plan from the World Bank, and finance minister Nirmala Sitharaman had made to the Sri Lankan finance minister Ali Sabry in Washington during the spring meetings in April. A team from International Monetary Fund (IMF) has now begin negotiations with officials in Colombo over the bail-out plan including tough reforms needed by the government for financial support.

As public anger over the mismanagement of the situation by President Gotabaya and his brother Prime Minister Mahinda had spilled on to the streets, the Modi government had kept a close watch on the situation, but sought to keep a distance from the Sri Lankan leadership. Apart from the instability that the situation in the neighbouring country generates in South Asia, New Delhi has also been worried about a rise in refugees fleeing food shortages and other heart shaped on the Iceland nation. - Sandipa Bose

According to authorities involved in the matter, local automakers like TATA were not in favour of lowering import tax for Tesla or other manufacturers who chose to take the import route, instead of manufacturing in India. TATA now being a major player in the EV game, with nearly 30,000 electric cars sold in less than 2 years, felt the move would kill the local industry which contributed to the Indian economy.

Elon Musk's Tesla will now have to wait a little longer, and in the meantime the company has

once again shifted the deadline to land on India as Government of India wins the round one of debate.

Irrespective of the players, India gears up to aggressively deploy electric vehicles by 2030, but it will for now have to depend on local players to chase the dream. The popularity and sales of electric vehicles were increasing rapidly in the country. Hence, Indian


## Sedition law revisited by Supreme court

Sedition Law under Section 124A of the IPC stated that people who used words or signs to incite dissent against the lawfully established government were subjected to imprisonment. Thomas Macaulay drafted this law in the Indian

Penal Code during the colonial rule of the British. Underlining a constitutional court's duty to protect civil liberties, the Supreme Court recently put on hold the 152-year-old colonial-era penal provision of sedition in India.

The sedition law was largely used by the British to control the independence

movement. Prominent freedom fighters like Bal Gangadhar Tilak, Annie Bessant, Maulana Azad, Mahatma Gandhi were curbed and arrested under this law. This law was overlooked during inclusion in the Indian Penal Code in 1860. However, this was slightly rectified in 1890 through the Special Act XVII and sedition was included as an offense



Thappar v. State of Madrad (1950), Tara Song Gopi Chand v. The State (1951), Ram Nandan v. State of Uttar Pradesh (1959), Balwant Singh v. State of Punjab (1995), Arjun Jaitley v. State of Uttar Pradesh (2016). These rulings communicate that

awful opposition of the government cannot be accused as sedition. The onus of distinguishing between sedition and lawful dissent lies on the police making the arrest. Despite various ambiguities surrounding the sedition law, the validity of it was upheld during the Kedarnath ruling. In Dr. Vinayak en y. State of Chhattisgarh (2011), the

Binayak Sen v. State of Chhattisgarh (2011), the court held that a person responsible for circulating seditious content is punishable under the act. There have been attempts by the court to eliminate the misuse of sedition law. The court propagated that if a speech induces public disorder only then should it be considered as seditious. This is not

## Musk drops India plans for now

India and Indians have been excited for quite some time since 2019 when the government came up with the FAME 2 scheme to introduce electric vehicles on Indian roads, but FAME 2 is an extension of the FAME 1 introduced in 2015, which failed to make the noise in those days.

The idea of modern day electric car came from Tesla, and it was

speculated to run on Indian roads in few years' time, but the plan is now believed to be shelved. The issue had been a clash between the two involved, Government of India and Elon Musk. Government of India wanted to promote futuristic technology, but at the same time wanted them to procure locally to cut

under 124A IPC.

During colonial rule the punishment for violating the sedition law was exile from one's home country. Later in 1955 the punishment for the aforementioned law was amended to life imprisonment.

There had been several instances of abuse of this law in the past. There are multiple allegations that this law had been wrongfully used to curb freedom of speech of the people. Some of the legal challenges to the IPC Section 124A can be observed in Romesh included in the Section 124A of the IPC.

Owing to ambiguous nature and repeated misuse of the law, the relevance of this colonial law is being revisited by the Supreme Court currently. The law is not being revoked as long as it is not being reviewed. The Court expects the High courts to co-operate and not accept any FIRs under this section. People who have been jailed under this non-bailable colonial British era law can now approach the trial courts for bail.

# **Covid photos win Pulitzer for Danish posthumously**

He may not be capturing history from behind his lenses today, but the images he left behind are still winning hearts and prizes. Ace photojournalist Danish Siddiqui was honoured with the prestigious Pulitzer Prize 2022 posthumously alongwith three Indian photographers in the feature photography section.

On Monday, Siddiqui and his Indian Reuters colleagues Sanna Irsad Matto, Adnan Abidi and Amit Dave won for, "images of Covid's toll in India that balanced intimacy and devastation, while offering viewers a heightened sense of place", according to Pulitzer Prizes website.

Siddiqui was one of the most talented and renowned photojournalist in India. He got his first Pulitzer

prize in 2018, in feature photography as a staff of Reuters, for his documenting series "the plight of Myanmar's minority Rohingya community and their mass departure to Bangladesh". At the age of 38, he died while covering the Taliban-Afghan army battle in 16th July 2021. He was slain in a crossfire by the Taliban militiamen during the fight in Kandahar's Spin Boldak district. "We feel proud of him, but we miss him" – said Danish's father Akhtar Siddiqui after the announcement from the Pulitzer Prize.

Akhtar Siddiqui also said in his son's memories, "Danish went around the country, in the hospitals, in the Covid-19 wards, mortuaries, graveyards. He overworked during those days. His view was to show how the people were suffering and to let the world know about it so that we could collectively help people come out of this great disaster." --Sneha Paul

## Jordaar legal wrangle

Jayeshbhai Jordaar released on May 13, but with a disclaimer accompanying it.

The trailer of the film was released a few days before. It got a good response from fans to critics. But there was a scene of gender test before delivery, which created a controversy. A PIL was filed in the Delhi High Court seeking deletion of a certain scene from the movie which purportedly denounces female foeticide.

According to the petitioners, it was a legal offence to know the sex of the child before delivery, since this scene in the film is promoting such things, it should be removed. Even though the film is against female foeticide, it has promoted the ultrasound technology.

In the PIL it was stated, "in the ultrasound clinic scene without censoring the gender test is being shown openly, publicized. This is not permitted under sections 3, 3A, 3B, 4, 6 and 22 of the PC and

PNDT Act and hence this instant PIL has been filed."

The Delhi High Court asked the makers of Jayeshbhai Jordaar to insert in certain scenes a disclaimer concerning the illegality of the practice of sex determination of a foetus and gave its nod to the release of the Ranveer Singh-starrer film. A bench headed by Justice Navin Chawla asked Yash Raj Films to insert a prominent disclaimer in two scenes and said, "if you are sending a message, send it loud."

"We appreciate the message but you have to tell people that it is an offence," said the bench -- also comprising Justice Manoj Kumar Ohri. "Ensure that the disclaimer appears at both the times," it told the filmmakers. -Kasturi Banerjee

Warhol's Andy Sage Blue Shot Marilyn", a portrait of iconic American Marilyn actress Monroe, has been auctioned for a recordbreaking \$195m (£157.8m), making the iconic portrait of Marilyn

Monroe, the most expensive artwork by a US artist ever sold at auction.

The portrait auctioned on Monday portrays Monroe in vibrant close-up, yellow coloured hair, blue eyeshadow, and red lips- on a turquoise background. "Shot Sage Blue Marilyn is the absolute pinnacle of American pop", said Alex Rotter, said the chairman of Christie's 20/21 Art Department, in a statement announcing the auction.

Warhol's painting was held in the collection of

auctioned at The Christie's in New York on May 9. According to Christie's auction house in New York, where the sale took place, Warhol's portrait is the most expensive piece from the 20th century ever auctioned, as per the New York Times Ahead of the auction, Christie's wrote that the

painting is "one of the rarest and most transcendent images in existence", with a selling price "in the region" of \$200m. The auction ended with a sale price of \$170m, which rose to \$195m with taxes and fees taken into account.

The previous record price for a piece of American artwork was \$110.5m for a skull painting created in 1982 by Warhol's sometimes friend and sometimes competitor, Jean-Michael Basquiat. The final price also smashed the previous record for a 20th Century work of art, set in 2015 when a 1955 painting by Pablo Picasso - Les Femmes d'Alger (Version O) - sold for \$179.4m, including fees.

# Indian men enter the elite class

magine the monkey India has been carrying for the last 73 years was finally off to the back, as the Indian shuttlers became the world team champions winning the first ever Thomas Cup at the Impact Arena in Thailand defeating defending champions Indonesia 3-0.

Earlier, the Indian men's badminton team scripted nistory after reaching their maiden Thomas Cup final with 3-2 win over Denmark in a thrilling semifinal on Friday. Indian men had previously reached the Thomas Cup semis in 1952, 1955 and 1979, but never beyond that.

Indian men had sporadically made India proud ike the monumental first ever winner of the All England Open via Prakash Padukone in 1980. Piullela Gopichand repeated the feat in 2001. Kidami Srikanth became World No 1 in 2017. But as a team, India never hogged the glory.

Playing their first Thomas Cup semis in 43 years, India kicked off their final four fixture at the Impact Arena with Lakshya Sen, ninth in the badminton world rankings, facing off against world No 1 and Olympic champion Viktor Axelsen. This was the wo shuttlers' third clash of the year. While the Indian youngster shocked the Danish ace in the German Open semis in March, Axelsen registered he win in the All England Open final later that month.

But on May 15 all that became history when India on Sunday won their first Thomas Cup title after beating holders and 14-time champions Indonesia 3-0 in the final.

Kidambi Srikanth defeated Jonatan Christie in straight games 21-15, 23-21 as India sealed the title without losing a match.

Earlier, India had taken a 2-0 lead after Satwiksairaj Rankireddey and Chirag Shetty came from game down to beat Mohammad Ahsan and Kevin Sanjaya Sukamuljo 18-21, 23-21, 21-19. That came after Lakshya Sen gave India a 1-0 lead after beating Indonesia's Anthony Ginting in the first match.

After losing the first set 8-21, Sen made remarkable comeback in the second game, before also shurgging off a four-point deficit in the third game. Sen defeated Ginting 8-21, 21-17, 21-16 in a match that lasted for an hour and five minutes. Ginting took the first game 21-8 before Sen edged him in the second by 21-7. This win would surely set the course for men's badminton and give it the required momentum.

# Rise and fall of the Manchester siblings

For quite a long time, Manchester City was known as the younger sibling of United, looking as the Reds progressed. For several years, Manchester United effectively dealt with their inferior rivals in derbies, as it was just the situation of a league champion meeting face to face an antiphonary mid-table group.

Nonetheless, those years have passed, as Manchester City has won the English Premier League five times in the last ten years, ending the conclusion of an important period that gave them little to be amped up for. On the other hand, as United's downfall began, they have just won one league title in the last ten years.

The most crucial turning point for Manchester United was in 2013 when Sir Alex Ferguson left the club after a record tenure of 27 years. At the time when Sir Alex retired from football alongside CEO David Gill. Thereafter, as has been broadly covered and seen by the majority, Manchester United have failed to win any significant trophies for a reliable period, and as of today is on a dry run of five years with practically no trophies. Thus, after the departure of long-term director Sir Alex Ferguson, Manchester United has continuously lost its character as a predominant football club. The summer of 2008 marked the start of a new chapter for the Cityzens, as Manchester City were purchased by the Abu Dhabi United Group, who have, for an absence of better words, boatloads of cash. Curren to win the first ever Wimbledon at the age of 17, Boris Franz Becker hardly knew he would

spend a part of latter life inside a prison cell. German tennis legend Becker was finding it difficult to adjust in his early stage of prison sentence at HMP Wandsworth. He reportedly complained about quality & quantity of food, poky nature of the cell & lack of hygiene. He was sentenced to two and half years, for hiding the assets worth £2.5million during bankruptcy proceedings, which began in 2017.

Becker, who used to live in the lap of luxury, was currently struggling to adapt to prison life and certain restrictions. He was utterly disappointed about the standard of food provided to him. He told his family and friends about that after being served corned beef, which was one of his first meals in Wandsworth Jail, which was not good enough to him. "He is having a rough time and the worst thing of all is the food. He cannot believe how bad

When he stunned the world by defeating Kevin it is and how small the portions are, someone close to him told newspapers.

The six time Grand Slam Champion had a love for



Cuban cigars, fine wines & restaurants. Now he was compelled to use the given £10 weekly allowance in jail, by grabbing extra foods like chocolate, biscuits & bananas from the canteen to counterbalance his

disappointment about food.

Reports said that he was also shocked about the lack of hygiene & stuffy ambience of the prison as

it was way too overcrowded. According to a source, he has supposed to have said: "The conditions are miserable, almost inhumane. It can get cold in the cells and there's hardly any daylight." He also moaned that due to the 'constant noise' and stink of the prison, he was suffering from lack of sleep in his six square metre cell, where he remained from 8PM to 7AM.

However, Becker was likely to spend 15 months behind the bars, and serve the rest of his term on licence. He was expected to be transferred to a 'softer jail', which would be a lower security prison in the

Pic: Internet near future. But, fate could be more cruel on the German legend as the British Home Office confirmed that there was a possibility that he might be deported from the UK after the end of his imprisonment. He had lived in Britain since 2012

but could be sent out of the country, as he did not have British citizenship.

The initial stage of prison life had been rough for Becker. He was spending a tough time in jail while trying to fit in there, as he had always been accustomed to leading a lavish & luxurious life. This fall from grace & dwelling against this disaster after achieving so much success in life, was something that experts felt would transform him for better or completely break him.

He shot to fame by setting the record for Wimbledon, becoming the youngest player ever to win the men's final. He was also the first unseeded player ever and the first German to win the men's single title at Wimbledon. He was nicknamed "Boom Boom" for his huge serve. Becker reached the Wimbledon final 7 times in 10 years and won 3 men's single titles, among the total of 49 singles and 15 doubles victories over the course of his career. He ranked third in sport career earnings with \$25,080,956. But pressures and demands on him brought too much stress into his life. --Soumyadip De
